Original articles, short articles and reviews received in Spanish will be translated into English and published in both languages.

For writing manuscripts on clinical trials, indicate that the paper follows all the standards issued by the Spanish Agency of Medicinal Products and Medical Devices, available at: <http://www.aemps.gob.es/investigacionClinica/medicamentos/ensayosClinicos.htm>; and appears in the Spanish Clinical Studies Registry (the identification code must be included in the published article).

All signing authors of an article accept their responsibility as defined by the International Committee of Medical Journal Editors (available at <http://www.icmje.org> and in Farmacia Hospitalaria)

Submitted studies, if they were performed with people or animals, must have been previously evaluated and authorised by Clinical Research Ethics Committees (CREC) and must confirm that they comply with the basic principles of the World Medical Association's Helsinki Declaration (text available at: <https://www.wma.net/what-we-do/medical-ethics/declaration-of-helsinki/>)
